CALEA Update: CALEA will be accepting 6th edition comments until August 19, 2016. Also, the SRIC is proposing some changes to several standards and they have placed them on the CALEA Forum II for public comment.

Assessor Training: CALEA is now training Team Leaders and Assessors on Webinars since IRS Rules dictate if Team Leaders and Assessors go somewhere to be trained CALEA has to pay them so CALEA opted for the Webinar training. Both Chief Kulhawik (Norwalk) and Chief DeMayo (Clinton) have done the Team Leader Webinar training which lasted around three hours and consists of a Powerpoint Presentation and question and answer session via WebEx.

CALEA Conference Baltimore:

The SRIC has proposed new standards in the following areas:

- Training 7.48 – new standard related to firearms
- Communications - related to texting 911 for 3.2.5 and removed words command in 3.6.6
- Law Enforcement 41.2.7 – Mental Illness training and language and 84.1.6 property and evidence – storage of explosive

Chief Palmer attended the PAC Presidents Meeting – CALEA commented that new standards will most likely be done in phases to allow agencies to comply after the November Commission meeting.

POST Update: B. Tanner advises he is trying to schedule a Shelton State Onsite. Also Danbury and Naugatuck have completed the Tier1 State Onsite and are awaiting the final report.

New Business:
